#### **Product name**

#### **Product description**

Characterized by a low content of harmful water-soluble Cr (VI). It is primarily used where cement slurry may come into contact with human skin (screeds, adhesives for wall and floor tiles, dry plaster mixes, mortars, etc.). It is suitable for the production of dry plaster mixes, masonry cement mortars, cement adhesives, concrete mixes of qualitatively higher classes. It is also used in the production of strength-demanding concrete structures, for prestressed concrete, concrete against aggressive waters, reinforced concrete, concrete products, prefabs and everywhere where rapid demoulding is required within 24 hours. It also allows concreting even in cold and frosty environments, below 5 °C, where it can be processed using special additives.

The cement is delivered by two methods. It is packed in 25 kg bag and delivered on wooden pallets. It is also delivered in tank cars and RAJ type wagon on rails.

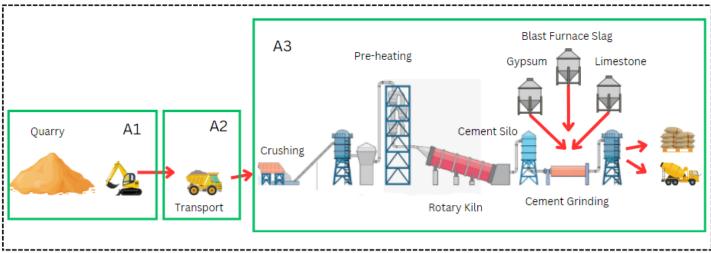

### Manufacturing process

The basic raw materials are limestone and marlite from the Butkov quarry, which, after grinding with the necessary additives, are ground into a fine meal and dispensed into the rotary kiln system in a controlled manner, and at a temperature of 1450 °C Portland clinker is formed, it is then ground with additives - gypsum, limestone, blast furnace slag, fly ash and others, and the resulting product is cement. Half of the cement is then packed into 25kg bags and transported on wooden pallets. The other half is transported in silo tanks by either rail or truck.

## Life cycle assessment (LCA)

#### **Cut-off criteria**

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.



#### Allocation, estimations and assumptions

Allocation is based on annual production rate and made with high accuracy and precision. The values for 1 tonne of the products which are used within this study are calculated by considering the total product weight per annual production. In the production plant, several kinds of products are produced; since the production processes of these products are similar, the annual production percentages are taken into consideration for allocation. According to the ratio of the annual production of the declared product to the total annual production at the factory, the annual total energy consumption, packaging materials and the generated waste per the declared product are allocated. Subsequently, the produced products output fixed to 1 tonne and the corresponding amount of product is used in the calculations.

#### Database(s) and LCA software

This EPD has been created using One Click LCA Pre-Verified EPD Generator. Ecoinvent v3.8 and One Click LCA databases were used as sources of environmental data. Characterization factors CML-IA version 4.1 have been used throughout the study.
